Initial _____

COACHING STAFF

All coaching volunteers over the age of 18 who have contact with the youth participants (including Team Moms, play counters, and anyone on the sideline roster) **MUST** have the following items on file with the LWYFL Board of Directors: a current NYSCA certification number and a completed state background check. ***Coaches/assistant coaches must also have a completed coaching application on file.** All fees are the responsibility of the applicant. The LWYFL will notify all coaches when and how they need to submit their NYSCA and background check data. Volunteers under the age of 18 are exempt but must be supervised by an approved coach. It is the responsibility of the head coach that all information for all volunteers is on file. Anyone found interacting with youth participants without the proper documentation will result in Head Coach disciplinary action.

ASSIGNMENT OF PARTICIPANTS TO TEAMS

Initial _____

The Board of Directors supervise the player draft. Teams are divided into multiple colors including Maroon, White, Black or Silver. The Board of Directors assigns team colors to each coach. All siblings are assigned to the same color/team unless otherwise requested or team color is not available. Only returning football coaches are allowed to protect players. Only one football coach per team may participate in the draft. Registration rosters are available the day of the draft. Each football player must play a minimum of 5 plays per half. Cheer teams are formed based on the football draft, siblings, years experience and registration numbers.

VOLUNTEERISM

Initial _____

The LWYFL has adopted a Team Day Volunteer Program. Each participant must have 1 grownup contribute 1 volunteer shift per season. This includes all coaching staff, board members and team moms. A volunteer shift takes place at our home field during a game that your child does NOT play. You will not miss any playing time for your child. Additional information will be given at the Parent Meeting May 15, 2011. It is the coach's responsibility that all volunteers show up for their scheduled duties. In the event a volunteer doesn't show, the coach is responsible to fill the vacancy either him/herself or with another volunteer.

EQUIPMENT POLICY

Initial _____

I acknowledge that I am responsible for returning all LWYFL issued equipment (such as tackling dummies, footballs, etc.) at the end of the season in acceptable condition. I agree to pay the replacement cost for any equipment issued to me that is lost or damaged beyond normal wear. I understand that trophies will not be released until all participant equipment has been returned.

COACH'S CODE OF ETHICS

I hereby pledge to provide positive support, care and encouragement for the children participating in youth sports by following the WOJFC Coach's Code of Ethics:

- I will insure that the children of the WOJFC play in a safe and healthy environment.
- I will encourage good sportsmanship by demonstrating positive support for all players, coaches, and officials at every game, practice or other youth sports event.
- I will support the opposing coaches and officials working with the children of my team, in order to encourage a positive and enjoyable experience for all.
- I will place the emotional and physical well being of the children of the WOJFC ahead of my personal desire to win.
- I will receive or renew my NYSCA coaches training and be trained in the responsibilities of being a youth sports coach. I will apply for and pass the required WOJFC background check to be eligible for Coach.
- I agree to uphold the WOJFC Constitution, By-Laws, Playing Rules, Rulings, Decisions, and the WOJFC Coach's Code of Ethics.
- I will aid the WOJFC and its members in securing a sports environment for the children of the WOJFC that is free from drugs, alcohol, tobacco and profanity. I will refrain from their use at all youth sports events. Events include all on field activities, as well as any team function.
- I will remember that the game is for youth – not adults. I will do my very best to make youth sports fun for all the children of the WOJFC.
- I will treat other players, coaches, fans and officials with respect regardless of race, sex, creed or ability.
- I will conduct myself in a positive manor that sets a good example for the children at all sporting events, by doing whatever I can, such as being a respectful fan, assisting with coaching or providing help where needed.
- I will agree to follow all the rules and guidelines set down by my club and the WOJFC and will abide by the decisions handed down by those organizations.
