REGISTRATION FEES AND REFUND POLICY

Initial _____

The registration fee for participation in LWYFL is \$125 per participant. Families with more than one participant pay as follows: the 1st child pays the current rate, the 2nd child pays 75% of the current rate and each additional child pays 50% of the current rate each. By signing the registration form, I acknowledge, understand, and agree to the following: REGISTRATION FEES ARE NON-REFUNDABLE.

ASSIGNMENT OF PARTICIPANTS TO TEAMS

Initial _____

The Board of Directors supervise the player draft. Teams are divided into multiple colors including Maroon, White, Black or Silver. All siblings are assigned to the same color/team unless otherwise requested or team color is not available. Requests to play a specific team or to be on a team with a friend are not permitted.

MEDICAL

Initial _____

LWYFL requires all football participants to have a physical check up as deemed by the WOJFC. Physicals must be in the 2009. Physicals dated prior to 1/1/2009 will NOT be accepted by the WOJFC. ****ONLY THE WOJFC 3 PART PHYSICAL FORM WILL BE ACCEPTED.****

VOLUNTEERISM

Initial _____

The LWYFL is a volunteer organization. Ten volunteers are needed for each game-2 concession workers, 1 gate worker, 1 spirit wear worker, 1 announcer, 1 clock runner, 1 spotter and 3 chain workers. This does not include the members of the board who are also on hand to collect garbage, run for supplies, grill, etc. The concession, gate and spirit wear workers will work the 1 ½ hours prior to the scheduled time of their participants game. Announcer, clock, spotter and chains will work during their participants game. If there are no volunteers for all 10 positions, the games cannot be played. Each family, including assistant coaches' families, must volunteer at least 2 games. If a team does not provide volunteers, or volunteers do not show up, Head Coaches and Team Moms will be required to fill those positions.

EQUIPMENT POLICY

Initial _____

I acknowledge that I am responsible for returning all LWYFL issued equipment/uniform at the end of the season in acceptable condition. I agree to pay the replacement cost for any equipment issued to my child lost or damaged beyond normal wear. If the borrowed equipment is not returned, my child will not be permitted to register for the next season until the equipment has been returned.

PARENTS CODE OF ETHICS

Initial _____

I hereby pledge to provide positive support, care and encouragement for my child participating in youth sports by following this Parents' Code of Ethics:

I will encourage good sportsmanship by demonstrating positive support for all players, coaches, and officials at all LWYFL and WOJFC practices, games, functions and youth sports events.

I will place the emotional and physical well being of my child ahead of my personal desire to win.

I will insist my child play in a safe and healthy environment.

I will require that my child's coach be trained in the responsibilities of being a youth sports coach and that the coach uphold the Coaches' Code of Ethics.

I will support coaches and officials working with my child, in order to encourage a positive and enjoyable experience for all.

I will demand a sports environment for my child that is free from drugs, alcohol, tobacco, and profanity and I will refrain from their use at all LWYFL and WOJFC practices, games, functions and youth sports events.

I will remember that the game is for youth and not adults.

I will do very best to make youth sports fun for my child and all of the children of the LWYFL and WOJFC.

I will ask my child to treat other players, coaches, fans, and officials with respect regardless of race, sex, creed or ability.

I will help my child enjoy the youth sports experience by conducting myself in a positive manner that sets a good example for the children at all LWYFL and WOJFC practices, games, functions and youth sporting events, by doing whatever I can such as being a respectful fan, and providing assistance where needed.

I agree to follow all of the rules and guidelines as set down by the LWYFL and by the WOJFC, to which my organization belongs, and abide by the interpretation and/or decisions handed down by those organizations. I/we hold harmless the LWYFL Board of Directors for any decisions or interpretations they may make regarding the status of my continued participation/membership or the participation/membership of the registered participant.
